THEY ALSO CAME FROM OTHER STATES. WE ARE AN ALL VOLUNTEER, FOSTER-BASED ORGANIZATION. SAFE HARBOR'S VOLUNTEERS RESCUED AND CARED FOR APPROXIMATELY 200 LABS IN 2024 AND OVER 4,700 LABS SINCE ITS FOUNDING. NEARLY HALF CAME FROM COMMUNITY MEMBERS WHO NEEDED TO SURRENDER THEIR LAB DUE TO A CHALLENGING CHANGE IN CIRCUMSTANCES. OTHERS CAME FROM CROWDED UNDER-RESOURCED SHELTERS OR RESCUE PARTNERS. SAFE HARBOR, A RESCUE LICENSED BY THE STATE OF COLORADO, DISTINGUISHES ITSELF BY PROVIDING SUPERIOR MEDICAL CARE, COMPASSIONATE FOSTERING, CAREFUL PLACEMENT, AND SUPPORT OF ADOPTERS.
